INTRODUCTION

Australian Taekwondo Queensland (ATQ) as part of its Strategic Plan 2019-20 identified to provide International and Olympic pathways to its athletes, coaches and officials by providing financial support.

PURPOSE

The purpose of this policy is to provide clear and transparent policy in relation to eligibility to obtain financial support from Australian Taekwondo Queensland (ATQ)

SCOPE

This applies to members of ATQ who have held continuous membership for 12 months or more. Including-

- (a) Athletes
- (b) Coaches
- (c) Officials.

POLICY

ATQ will provide financial support to any athlete, coach or official who is selected to represent Australia at any World Taekwondo World Championships, World Taekwondo Grand Prix Event, or Olympic Games including Paralympics.

ATQ will provide \$500 support for WT World Championship, or WT Grand Prix event.

ATQ will provide \$1000 support for the Olympic Games event.

ATQ will not provide financial support for any athlete, official, or coach who is funded by Australian Taekwondo, World Taekwondo or other group.

Upon providing funding all athletes, coaches and officials must allow ATQ to publicly, through social media, internet platforms and other platforms advertise this financial support.

ATQ will only provide financial support to applicants who have held 12 months or more continuous membership of ATQ prior to being selected to represent Australia. This includes cadets and juniors.

ATQ will consider the athlete's, coach's or official's support for Australian Taekwondo or ATQ in the previous 12 months in its considerations for funding.

APPLICATION METHOD

The application can be made upon being selected by Australian Taekwondo, Australian Olympic Committee, International Olympic Committee or World Taekwondo to compete at the nominated events.

Proof of such selection shall be provided by the applicant or guardian.

The application may also be made within 6 months of the return of the athlete, coach or official from the event.

Applications will not be accepted outside of these dates.

Results of the event shall be provided where possible by the applicant or guardian.

Such application should also contain support shown by the athlete, coach, or official at Australian Taekwondo and ATQ events.

CONSIDERATIONS

All applications should be sent via email to contact@qldtkd.com.au with all relevant attachments.

ATQ will consider such application and information supplied at the first board meeting upon receiving the application.

Within 24 hours of such deliberations the applicant or guardian will be provided the result of their application.
